## Post-2020 global biodiversity framework: a recipe for success

Sunday 5 September 2021: 08.30 – 12.30; Room H8 - 2 Forêt d'Orient; Onsite - Face-to face event
This session will discuss the draft post-2020 global biodiversity framework (GBF), to be adopted at CBD COP15. We will share views and discuss whether the GBF is truly "fit for purpose" to halt the loss of biodiversity by 2030. Come and express your opinion - to encourage the world's governments to make the right decisions at CBD COP15.

#### Overview

At the time of writing, the post-2020 global biodiversity framework is available in the form of a "First Draft" - for adoption at the UN Biodiversity Conference in Kunming, China, following negotiations by Parties to the Convention on Biological Diversity at the Open Ended Working Group third meeting (OEWG-3.1, and subsequent meetings).

This session will take place immediately after the close of the OEWG-3 (scheduled for 23 August – 3 September). It will review the draft that emerges from this meeting (that will not be formally closed, but rather suspended) and highlight key points that ensure that it is "fit for purpose" to tackle the nature emergency by galvanising decisive action for nature at scale – commensurate with the challenge faced by the world.

Such action is now imperative from local to global levels, from all countries and all sectors across all realms (land, freshwater and ocean) to secure the planet's life-supporting 'safety net'. Please come to this onsite event and make your views known.

## **Detailed description**

Nature is declining globally at rates unprecedented in human history. A complete change to the current way of living - transformational change - is vital to achieve the 2050 vision of Living in Harmony with Nature. The post-2020 global biodiversity framework needs to galvanise decisive action for nature at scale. This is imperative from local to global levels, from all countries and all sectors across all realms (land, freshwater and ocean).

The "First Draft" post-2020 global biodiversity framework, and what emerges from OEWG-3.1, will be the basis for discussions at this highly participatory session. The session will focus on what must be done to ensure the adoption of a post-2020 global biodiversity framework that will secure the life support systems of this planet.

The Mission of the framework (as currently drafted), is "To take urgent action across society to conserve and sustainably use biodiversity and ensure the fair and equitable sharing of benefits from the use of genetics resources, to put biodiversity on a path to recovery by 2030 for the benefit of planet and people".

**Design and format of the session:** The introduction will explain the draft framework. IUCN's position on the post-2020 global biodiversity framework is that it should halt the loss of biodiversity by 2030, and achieve recovery and restoration by 2050 ('bending the curve of biodiversity loss'). We also believe that a truly global framework for biodiversity conservation is needed for all stakeholders in society.
